

## TNT Tennis Guidelines Fall 2025

- TNT Registration must be made by Thursday Aug. 28, 2025. A team representative must submit a team roster of lines 1-4 assigned players, pay the \$25 TNT team fee, and confirm team contact information. You may submit your roster via email to Kim Ramagos, Secretary/Treasurer and Maria Treme, Vice President. Payment can be made via Venmo to Kim Ramagos or by check made payable to TNT Tennis. Those teams finishing 1<sup>st</sup>, 2<sup>nd</sup>, or 3<sup>rd</sup> in the division standings last season do not owe a team fee this season: Well done!
  - If you cannot send rosters and payment via email/Venmo before Thursday 8/28/25 you must deliver your team roster and payment to me, Phyllis Smith, or Maria Treme at Green Acres, Thursday Aug. 28, 6:30 pm.
  - TNT play starts Thursday, Sept. 4 and ends around Thanksgiving. There are 10 teams in RED, 10 teams in WHITE, and 12 teams in BLUE. Schedules will be emailed and posted to the website: [www.thursdaynighttennis.com](http://www.thursdaynighttennis.com).
1. Your final roster must be submitted before play starts.
  2. Players may play individually on any line during an evening match; but a line rostered team may only play together in their rostered spot. No players may play together twice in one night.
  3. Substitute players may play on more than one team provided those teams are in different divisions and that the player is not assigned to a line rostered position on any TNT team.
  4. At City Park the host team Captain is responsible for cancelling her original courts and rescheduling her match if it cannot be played as scheduled due to reasons other than closure by City Park tennis. Line cancellations need to be emailed to Stephanie Celino ([scelino@nocp.org](mailto:scelino@nocp.org)) AT LEAST 24 hours prior to the scheduled match. Fees are \$147 per match night and must be paid by the team directly to City Park via phone or in person the night of the match.
  5. Arrive by 6:30 pm so that lines 1 and 3 are on the court at 6:45 pm sharp. (7 pm for City Park and Xavier). Line 1 and 3 default time is 7:05pm. Lines 2 and 4 should arrive by 7:45 and the default time is 8:05 pm if courts are available. Guest Captains must confirm times and place with the host Captains by Monday Night. NOTE: Should the teams agree to start earlier, the default time will be 20 minutes after the agreed upon time. For example, if lines 1 and 3 agree to start at 6:30 pm, then the default time will be 6:50 pm and the line 2 and 4 default time will be 7:50 pm if a court is available.
  6. Please pay attention to match locations on the schedule and confirm with the host Captain early in the week. Note: One Blue match will be played during the Blue Bye week. ( Those teams will get a bye the next week). Two White matches will be moved to Nov. 13 and Nov. 20 after most of the White teams have finished due to court availability constraints. Thus please pay attention to your team match dates.
  7. Updated contact lists will be distributed. Please advise of errors. Please check the website for rules, tie breaker procedures and other information. Bylaws are under the HOME tab.
  8. Please submit your scores to your scorekeeper by MONDAY following the match. Please note that failure by BOTH teams to submit scores or notice of a postponement by Wednesday may result in the team not submitting scores to be scored Zero. Please use the attached score sheet. Complete it, take a picture, and text it to the scorekeeper after the match. If it is for a make-up please note the original match date on it as well.
